

Privacy Statement J&J INSPECTIONS BV

Your privacy is of great importance to J & J INSPECTIONS BV. We therefore comply with the privacy law. This means that your data is safe with us and that we always use it properly. In this privacy statement we explain what we do with information that we learn about you.

Contact form

With the contact form you can ask us questions or make requests.

For this we use your telephone number, e-mail address and name and address details. We do this on the basis of your consent. We keep this information until we are sure that you are satisfied with our response.

Execution of work

We process personal data in so far that it is needed for the planning, performance and administration of our activities. This can apply to names, addresses, contact details and financial details.

We store this data for up to 7 years after the end of the work or for as long as necessary to represent our legitimate interests

If we process personal data for you during the performance of our assignment, we will do so in accordance with the applicable regulations. We archive Personal Data on the basis of our obligations, but never more data or longer term than necessary.

For the execution of our work we use our own employees as well as inspectors hired by us. All persons carrying out work are contractually bound to confidentiality

Provision of information of Inspectors to other companies or institutions

We pass on your details to our clients for assessment for the execution of work if we think that you are suitable for the opening at the time.

We also pass on your details if we are legally obliged, for example for administrative reasons, or if the competent authority requests the transfer of data

Security

Security of personal data is of great importance to us. We ensure that your data is properly secured with us. We always adjust security and pay attention to what can go wrong.

Your rights

If you have any questions or want to know what personal data we have of you, you can always contact us. See the contact details below.

With regard to your personal data, you have the following rights:

- receive an explanation of what personal data we have and what we do with it
- insight into the exact personal data we have
- to have errors corrected
- the removal of outdated personal data
- withdrawing permission
- object to a particular use

Please note that you always clearly state who you are, so that we can be sure that we do not modify or delete data from the wrong person. In some cases we will check your identity. We always respond to your request within 4 weeks.

Data protection officer
